

COVID-19 Health & Safety Measures

Our commitment to our guests, vendors, performers & volunteers:

Sunset Supper at Pike Place Market is a fully-vaccinated event for all guests, vendors, performers, staff and volunteers.
Proof of vaccine is required before entering the event.



We created contactless experiences:

Personal Protective Equipment is available for all attendees:

Face masks are available at the entrances and throughout the event.

Hand sanitizer and handwashing stations are available throughout the event.



Here's what you can do to protect yourself and those around you:

Stay at home if you are experiencing COVID-19 symptoms.

We recommend our guests to wear a mask when walking throughout the event. Guests may remove their masks to eat & drink while seated or standing away from other guests.

Respect all safety and health-related signs and instructions.



We will ensure safe interactions between our staff members and guests:

All event staff and volunteers are also required to be free of COVID-19 symptoms, show proof of vaccination, and recommend wearing a mask and maintaining high levels of hygiene through regular hand washing and the use of hand sanitizer.



We will create the safest possible environment:

Sunset Supper welcomes guests back at 80% capacity of total attendees and vendors. We abide by rigorous standards to ensure everyone in the event shows proof of vaccination. We will disinfect our event space frequently and encourage masks to be worn whenever possible.



At events, clear information regarding your safety will be a priority:

We communicate health and safety guidelines to all of our guests, vendors, performers and volunteers, so that every attendee is aware of the guidelines.

All event regulations, including health and safety information, will be available at the venue.

Our employees and volunteers will be fully trained on all safety measures and procedures.



Vaccination Policy: Sunset Supper at Pike Place Market on August 20, 2021 is a fully vaccinated event. It is the mission of the Pike Place Market Foundation to promote the health and well-being of Market workers, residents, and guests. In order to ensure this event is safe for our community, all Sunset Supper staff, volunteers, vendors, attendees, and performers must show proof of vaccination before entering the event (proof includes showing vaccine card, photo of vaccine card, or copy of email stating vaccine completion; full vaccine must have occurred before August 6, 2021).

The Market Foundation will ensure the event adheres to any current State, County, and City guidelines for social distancing, mask-wearing, etc. We reserve the right to make adjustments leading up to the event and will post vaccine requirements on our event webpage and at our event entrances.

I attest that: I am not experiencing any symptoms of illness such as cough, shortness of breath or difficulty breathing, fever, chills, repeated shaking with chills, muscle pain, headache, sore throat, or new loss of taste or smell. I do not believe I have been exposed to someone with a suspected and/or confirmed case of the Coronavirus/COVID-19. I have not been diagnosed with Coronavirus/Covid-19 and not yet cleared as non contagious by state or local public health authorities. I am following all CDC recommended guidelines as much as possible and limiting my exposure to the Coronavirus/COVID-19. I hereby release and agree to hold Pike Place Market Foundation harmless from, and waive on behalf of myself, my heirs, and any personal representatives any and all causes of action, claims, demands, damages, costs, expenses and compensation for damage or loss to myself and/or property that may be caused by any act, or failure to act of the organization, or that may otherwise arise in any way in connection with any services received from Pike Place Market Foundation. I understand that this release discharges Pike Place Market Foundation from any liability or claim that I, my heirs, or any personal representatives may have against the Pike Place Market Foundation with respect to any bodily injury, illness, death, medical treatment, or property damage that may arise from, or in connection to participating in Sunset Supper at Pike Place Market. This liability waiver and release extends to the Pike Place Market Foundation together with all owners, partners, and employees.
