## **Market Treasure Hunt Official Rules**

## NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

- 1) Eligibility: Pike Place Market Treasure Hunt ("Sweepstakes") is open only to those who are [18 years of age or older] as of the date of entry. The Sweepstakes is only open to legal residents of the United States and is void where prohibited by law. Employees of the Pike Place Market PDA Pike Place Market Foundation, its affiliates, subsidiaries, advertising and promotion agencies, and suppliers, (collectively the "Employees"), and immediate family members and/or those living in the same household of Employees are not eligible to participate in the Sweepstakes. The Sweepstakes is subject to all applicable federal, state, and local laws and regulations. Void where prohibited.

- 3) Sweepstakes Period: The Sweepstakes begins on Saturday, October 23, 2021 at 10 a.m. United States Pacific Time ("PT") and ends on Saturday, October 23, 2021 at 4 p.m. PT (the "promotion Period").
- 4) How to Enter: To be eligible, you must visit all 10 stops on Treasure Hunt map and obtain a stamp or pin to indicate you visited. Turn in your completed Treasure Hunt form with name, email, phone and zipcode at the "Event Information" table under the Pike Place Market Clock & Sign (Pike Place & Pike Street, Seattle, WA) before 4pm on Saturday, October 23rd, 2021. No purchase is required for entry.
- 5) How to Play: Visit all ten (10) locations listed on the Treasure Hunt card and obtain a stamp or a pin. Once your card is completed, turn it into the "Event Information" tent on Pike St and Pike Place.
  - Sponsor may disqualify any entries if it determines it is unlawful, or in violation of these Official Rules, all in its sole discretion. Released Parties (as defined in Section 8, below) are not responsible for lost, late, unreceived, damaged, incomplete, invalid, unintelligible, or delayed entries.
- 6) Drawings: The Sponsor will randomly select the potential winners from all eligible entries received during the applicable Entry Period. Each potential winner will be notified by the Pike Place Market Foundation via email and will be required to provide his/her name, email address, phone number and zip code to confirm eligibility and for prize fulfillment purposes within three (3) days of the date notice or attempted notice is sent in order to claim the prize. If a potential winner of any prize cannot be contacted, fails to provide any requested information within the required time period (if applicable), or the prize is returned as undeliverable, the potential winner is disqualified and forfeits his/her prize. Receiving a prize is contingent upon compliance with these Official Rules. In the event that a potential winner is disqualified for any reason, Sponsor will award the applicable prize to an alternate winner by random drawing from among all remaining

eligible entries. Only three (3) alternate drawings will be held, after which the prize will remain un-awarded.

7) Prizes: Winner will receive two (2) round trip economy airline tickets good within US50 Main Cabin. Tickets are to be used within the continental U.S. and used before October 1, 2022. Vouchers cannot be replaced if lost, stolen or expire. Baggage fees, tax and additional fees are the responsibility of the passenger(s).

**For All Prizes:** All prize details, including but not limited to color, size, style, and model, will be determined by Sponsor in its sole discretion. Prizes are non-transferable and no substitution will be made except as provided herein at the Sponsor's sole discretion.

In such event, Sponsor, in its sole discretion, may elect to hold a random drawing from among all eligible entries received up to the date of discontinuance for any or all of the prizes offered herein. Sponsor reserves the right, in its sole discretion, to disqualify any individual it finds to be tampering with the entry process or the operation of the Sweepstakes or to be acting in violation of the Official Rules of this or any other promotion or in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately undermine the legitimate operation of the Sweepstakes may be a violation of criminal and civil law, and, should such an attempt

- 11) Limitations of Liability: The Released Parties are not responsible for: (1) any incorrect or inaccurate information, whether caused by entrants, printing errors or by any of the equipment or programming associated with or utilized in the Sweepstakes; (2) technical failures of any kind, including, but not limited to malfunctions, interruptions, or disconnections in phone lines or network hardware or software; (3) unauthorized human intervention in any part of the entry process or the Sweepstakes; (4) technical or human error which may occur in the administration of the Sweepstakes or the processing of entries; (5) late, lost, undeliverable, damaged or stolen mail; or (6) any injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from entrant's participation in the Sweepstakes or receipt or use or misuse of any prize. - 12) Disputes: Except where prohibited, entrant agrees that: (1) any and all disputes, claims and causes of action arising out of or connected with this Sweepstakes or any prize awarded shall be resolved individually, without resort to any form of class action, and exclusively by the United States District Court for the Western District of Washington or the appropriate Washington State Court located in King County, Washington U.S.A.; (2) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Sweepstakes, but in no event attorneys' fees; and (3) under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim, indirect, punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased. All issues and guestions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of the entrant and Sponsor in connection with the Sweepstakes, shall be governed by, and construed in accordance with, the laws of the State of Washington, U.S.A. without giving effect to any choice of law or conflict of law rules (whether of the State of Washington or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the State of Washington.
