Event Details

- **Friday, August 19th**

Please arrive on time to enjoy all this event has to offer!

- 7:00 pm – Sunset Supper admission gates open for Patron guests **only** – **that's you!**
- 7:30 pm – Sunset Supper admission gates open for General Admission guests
- 11:00 pm – Sunset Supper ends
- Dress is cocktail party casual. You will be moving about on 115 year old cobblestone - high heels are not recommended!
- All guests must be 21 years or older with valid ID.
- **The Market Foundation is following all local and state health and safety guidelines regarding COVID-19.** While proof of vaccination and masks are not required, we encourage mask wearing when not eating or drinking. Please note that this policy is subject to change.

Patron Event Entry

- Your wristband is your ticket! All food and beverages are included in the ticket price. Please wear your wristband throughout the event.
- Bring your wristband and parking pass with you to the event. Replacements will not be issued.
- Look for Patron Entrances at:
 - **Main Entrance - Pine Street & Pike Place** (*Ticketed Entrance + Patron Will Call*)
 - **North Entrance - Virginia Street & Pike Place** (*Ticketed Entrance Only, usually shortest line*)
 - **MarketFront Entrance** accessible from the Pike Place Market Parking Garage Elevator - Floor 3. (*Ticketed Entrance for Patrons wearing wrist-bands ONLY.*)
- Tent and table locations will be emailed to table hosts prior to the event. Patron guests receive exclusive seating and wine service in their tent. Sunset Supper takes place in all weather events. Patron seating is under canopies.

Table Hosts

- **Guest lists (names and emails) are due by Friday, August 12th** to Jennifer.Schooley@pikeplacemarket.org. Names must be given for guests to utilize Will Call. Enter names online [here](#) or use the attached form.
- **Patron Packets will be available starting Monday, July 25** – Packets include wristbands, parking passes and event information. Your job is to share needed information with your guest(s) – thank you!

Transit & Parking

- Taking mass transit or an Uber/Lyft to and from the party is recommended
- Your Parking Pass will be distributed with your wristband. Parking is located at the **Public Market Parking Garage**. Enter at the 1531 Western Avenue or 1901 Western Ave entrance. Details and directions can be found here: <http://pikeplacemarket.org/directions-parking>
 - **When arriving, take a garage ticket and keep it with you.** A lost ticket cannot be replaced by your Sunset Supper parking pass and you will incur a \$30 charge
 - As a reminder, guests driving in will not be able to access the garage from Alaskan Way due to ongoing Waterfront construction
- Use your pass as you **exit** the garage. Insert your garage ticket into one of the pay kiosks or at the exit; when the amount due appears, insert your parking pass. Passes are valid 8/19/22 only.
